A New SIWIB Committee Is Born!

At the last Executive Committee meeting, the members voted to establish a new standing committee entitled "WIA Policy and Planning Committee." The WIA Policy and Planning Committee is charged with the oversight and development of WIA Title IB policy regarding the establishment of programs and services to assist employers meet their hiring needs. In the past, these issues were assigned to the Executive Committee or an *ad hoc* committee. It was felt that it would be in the best interest of the SIWIB to have a committee that focused primarily on WIA Title IB on an ongoing basis. This committee shall develop and make recommendations to the board and CLEOs regarding such policy. Other duties and responsibilities will include:

- recommending plan modifications or new plan submittals
- negotiating local performance measures
- reviewing and modifying supportive service policy
- reviewing and modifying the self-sufficiency policy
- reviewing, monitoring, and providing oversight of WIA Title IB programs
- monitoring achievement of performance standards and program outcomes
- reviewing and modifying local customer grievance procedures

■ establishing programs and services to assist employers in meeting their hiring needs by:

- identifying the appropriate assessment process and mix of core and intensive services
- identifying eligible providers of core, intensive and training services for adults and dislocated workers

— identifying training programs that will allow job seekers to select a training program directly linked to employment opportunities either in the local area, or in another area where the individual is willing to relocate, as identified by the Business and Economic Development Committee

— identifying training services that are directly linked to occupations that are in demand in the local area, or in another area where an adult or dislocated worker receiving such services is willing to relocate, as identified by the Business and Economic Development Committee. The board may approve training services for occupations determined by the board to be in sectors of the economy that have a high potential for sustained demand or growth in the local area.

— developing follow-up and retention services

SIWIB COMMITTEE PROJECT OVERVIEW

Executive Committee

The Executive Committee met on Tuesday, April 24th, and approved the consolidation of the duties of the Marketing Committee into the One-Stop Committee, and the creation of a new WIA Policy and Planning Committee.

In related business, the committee approved sending modifications of the SIWIB Bylaws to the Board at the annual meeting in June for review and adoption. The proposed modifications delete reference to the Marketing Committee and add the WIA Policy and Planning Committee as a standing committee. They will also be modified to extend current terms of appointment until October 1st, and will then change terms of appointment from July 1st through June 30th to October 1st through September 30th. The committee asks that the terms of appointment be changed to accommodate the state's request for an October 1st date for re-certifying all of the LWIBs in the state.

The committee ratified the submission of the WIRED SI grant (see article on page one of the April issue) in conjunction with Southern Illinois University.

In other business, the committee authorized the submission of a Board grant in the amount of \$50,000 to the Department of Commerce and Economic Opportunity (DCEO).

Director Lively reported that nearly \$2 million in tax refunds were processed through the tax counseling project this year. This is a 23% increase over last year.

There were approximately 400 individuals enrolled in the TAA program from the Technicolor Universal Media Services (TUMS) plant closure, and Ms. Lively expects 125 individuals to enroll for the summer semester. In addition she expects over 500 TAA-registered individuals to be enrolled in local colleges by fall of 2007.

Director Lively also reported that an Employment Opportunity Fair was

scheduled for Tuesday, May 15, 2007, from 9:00 a.m. until 1:00 p.m. at the Southern Illinois Center located on the south side of the Du Quoin State Fairgrounds.

Ms. Lively informed the committee that asset mapping and Readiness Assessment interviews are occurring throughout the 20 county region as part of Connect SI.

As of March 30th, there were 23,986 visits to our affiliate offices and One-Stop Centers. Funds in the amount of \$50,000 were made available for training workers already on worksites. These dollars came from the regular Title 1B Adult funding stream in the new Incumbent Worker Training initiative which allows Local Workforce Investment Boards to allocate up to 10% of a funding stream for this initiative.

Youth Council

The Youth Council met on April 11, 2007. The meeting was held to develop a summer program for WIA youth. Kate Stiles, Man-Tra-Con's summer youth coordinator, researched summer activities that would be most beneficial to the youth, and recommended classes offering a certificate upon completion. She felt that the CNA, Work Certified and Pharmacy Tech classes offered through John A. Logan College would best fit the requirements of a WIA Summer Program.

A survey of youth contractors showed that they would not have enough youth available to fill the classes. Kate suggested that the Council offer classes to all high school seniors who did not have specific plans after graduation. Since the deadline was so tight, the Council decided to only include schools in John A. Logan College's district that were offering JILG classes. It was suggested that DuQuoin High School be added because Man-Tra-Con's DuQuoin office has a lab that could be used for CNA classes. The Council considered including classes from Rend Lake College's District, but their CNA classes are full — a result of Rend Lake College's prerequisite of CNA course completion prior to starting LPN classes.

Dr. P. E. Cross serves as a distinguished member on the Youth Council of the Southern Illinois Workforce Investment Board.
