## SIWIB INITIATIVES UPDATE

### Energy Sustainability

The fourth and final discussion in the *Connecting with the Future of Energy* series will focus on *Energy Sustainability*. The event will be held on May 22, 2008, at the Dunn-Richmond Economic Development Center, 150 E. Pleasant Hill Road, Carbondale, with refreshments at 5:30 p.m. and the discussion beginning at 6:00 p.m. The session will cover energy consumption, geo-thermal energy, energy efficient housing, electric vehicles, green buildings, wind power, and more.

Donald Fournier will be the featured presenter. He will discuss energy consumption, where it comes from, and where it goes, from a national perspective. Mr. Fournier is on the University of Illinois Building Research Council as senior research specialist in the areas of sustainable design and development and energy efficiency. In his position, he develops indicators of sustainability for the built environment that are regionally weighted, evaluates urban growth within a dynamic modeling environment, evaluates environmental risk associated with rapid urban growth, models distributed generation

technologies, develops encroachment analysis and capability assessment techniques for military installations, and advises on energy policy, energy security, and green building rating systems for the U.S. Army. Don participates in several committees of the U.S. Green Building Council. He also develops and teaches Continuing Education courses in sustainable design and the architecture of sustainability.

Don also serves as program manager for the Smart Energy Design Assistance Center (SEDAC). The SEDAC provides advice and analyses enabling facilities in the State of Illinois to increase their profitability through the efficient use of energy resources. SEDAC is sponsored by the Illinois Department of Commerce and Economic Opportunity and provides valuable services at no cost to small businesses and public facilities. SEDAC is managed by the School of Architecture at the University of Illinois at Urbana-Champaign and the 360 Energy Group.

## SIWIB COMMITTEE PROJECT OVERVIEW

### Board Development Committee

The Board Development Committee met on Friday, April 25th at noon. The committee discussed details for the SIWIB Annual Meeting. The Annual Meeting is scheduled for June 19th after a telephone survey of the Board membership indicated that a quorum would be present. Twenty-two of the SIWIB members responded favorably about attending the meeting. There had been concerns about whether there would be a quorum at the meeting as there had been problems establishing a quorum at past Board meetings. The committee decided that a dinner for local award nominees would start at 5:00 p.m. with Great Boars of Fire catering the dinner. The awards ceremony is scheduled for 5:30 p.m. with the

meeting following the awards ceremony. Agenda items include ratification of the local workforce plan modifications dealing with the rescission of local WIA funds. New business will include approval of contracts and election of officers. The committee asked Mr. Hopkins to look into the possibility of playing bocce ball following the meeting. The committee reviewed SIWIB members' attendance at Board meetings. The committee asked Ms. Lively to talk to a few members about improving their attendance. The committee also discussed the need to replace a few members of the Board who were resigning or whose attendance was less than exemplary. Before adjourning the meeting the committee asked that Board members be surveyed prior to SIWIB meetings in order to establish quorums at future Board meetings. ■

## Tax Counseling Project A Huge Success

The Tax Counseling Project completed over 1,723 returns this year which is an 8% increase over the number of returns filed last year. Many of the tax returns were filed by single heads of house holds and most of them qualified for the Earned Income Tax Credit. An overwhelming majority of the tax returns were filed electronically which is the fastest method of receiving a tax refund. Almost all of this year's tax refunds (totaling nearly \$2 million dollars) were deposited directly into local bank accounts within ten to fourteen days.

The Marion Center has a tradition of completing the most returns outside of the Chicago area. The Marion Center was recognized as a model for the tax counseling project which prompted a visit by the Executive Director of the Center for Economic Progress, Mr. David Marzahl.
